### **ANSWER FOR DEFENDANT WILLIAM H. HUFFMAN**

COMES NOW Defendant William H. Huffman, III ("Defendant" or "Huffman"), and files his answer to Intervenor Plaintiff Willie A. Palmer, Jr.'s Amended Complaint. In response thereto, Huffman states as follows:

Huffman denies all allegations contained in any and all paragraphs set forth in Palmers' Complaint and supplements thereto (docs. 60, 70, 124, and 186) and demands strict proof thereof. Huffman claims ownership of the real property conveyed through deed Book 1607, Page Nos. 774-775 in the Probate Court of Dallas County dated September 8, 2020, and Deed Book 1609 Pages 538–39.

#### **JURY DEMAND**

Huffman hereby demands a trial by jury on all issues so triable.

## **AFFIRMATIVE DEFENSES**

Huffman reserves the right to modify and/or expand these defenses and to take further positions and raise additional defenses as discovery proceeds in this case. Huffman, without assuming any burden of pleadings, proof, or persuasion resting on Palmer, asserts the following affirmative defenses:

- 1. To the extent not expressly admitted, Huffman denies the material allegations of Palmer's Complaint and supplements thereto and demands strict proof thereof.
  - 2. Palmer fails to state a claim upon which relief may be granted.
  - 3. The allegations contained Palmer's Complaint are untrue.
- 4. Palmer's claims are barred by the statute of limitations, doctrine of repose, consent, and/or ratification.
  - 5. Palmer has not met the statutory requirements for quiet title action.

- 6. Palmer's Complaint is barred in whole or in part by the doctrine of estoppel.
- 7. Palmer's Complaint is barred in whole or in part by the doctrine of laches.
- 8. Palmer's Complaint is barred in whole or in part by the doctrine of waiver.
- 9. Huffman denies that Palmer has suffered any damages. To the extent that Palmer has suffered damages, such damages were caused by acts, events, or omissions outside of Huffman's control and for which Huffman is not legally liable.
- 10. Huffman denies that Palmer is entitled to the recovery of the nature, type and/or amount he seeks.
  - 11. Palmer failed to mitigate his damages, if any.
- 12. Palmer's Amended Complaint, and supplements thereto, is barred by the doctrine of unclean hands.
- 13. Palmer's Amended Complaint, and supplements thereto, is barred by the statute of frauds and/or the parol evidence rule.
  - 14. Huffman contests the nature of damages claimed by Palmer.
- 15. Huffman adopts and incorporates all available affirmative defenses listed in Ala. R. Civ. P. 8.
- 16. Any claim for punitive damages by Palmer is limited in whole or in part pursuant to the United States Constitution, the Constitution of Alabama, and applicable case and common law.
- 17. At the time of filing this Answer, Huffman has not completed discovery in this case. If the information obtained during discovery warrants the assertions of any additional defense in this action, Huffman reserves the right to amend this Answer to assert additional affirmative defenses.
