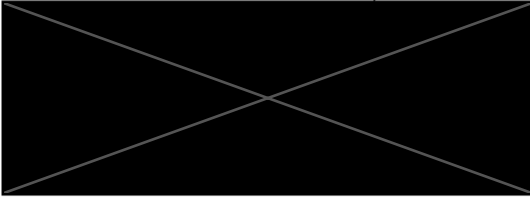

**COMPLAINT FOR EJECTMENT PURSUANT TO MISSISSIPPI
CODE TITLE 11 CHAPTER 19 AND FOR DAMAGES FOR THE
UNAUTHORIZED ENGAGEMENT OF TIMBER AND/OR MINERAL
OPERATIONS**

I, Jennine Labuzan-Delane, state as follows for my Complaint against the aforementioned Defendants:

Preliminary Statement

1. This is an action for ejectment pursuant to Mississippi Code Title 11 Chapter 19, arising from the fact that I am a direct heir of a patentee, Charles A. Labuzan. As a result, I have succeeded to his ownership of the United States Federal Land Patent Document Number 27859, December 10, 1840. As a direct heir of Charles A. Labuzan, the language of the said portion of Charles A. Labuzan Land Patent that proves that my title is good against the world, as an unbroken chain of title exists directly from the Sovereign United States Federal Government directly to me as an heir states: ***“NOW KNOW YE, That the UNITED STATES OF AMERICA, in consideration of the Premises, and in conformity with the several acts of Congress, in such case made and provided, HAVE GIVEN AND GRANTED, and by these presents DO GIVE AND GRANT, unto the said Frederick W. Schmidt, Robert L. Decoin, and Charles A. Labuzan and to their heirs, the said tract above described: TO HAVE AND TO HOLD the same, together with all the rights, privileges, immunities, and appurtenances of whatsoever nature, thereunto belonging, unto the said Frederick W. Schmidt, Robert L. Decoin, and Charles A. Labuzan and to their heirs and assigns forever.”***

3. In a December 2, 2001 Los Angeles Times Newspaper article by Todd Lewan and Dolores Barclay entitled, ***WHEN THEY STEAL YOUR LAND, THEY STEAL YOUR FUTURE***, the following was stated: “For generations,

black families passed down the tales in uneasy whispers: *'They stole our land.'* *These were family secrets shared after the children fell asleep—old stories locked in fear and shame. Some of those whispered bits of oral history, it turns out, are true. In an 18-month investigation, the Associated Press documented a pattern in which black Americans were cheated out of their land or driven from it through intimidation, violence and even murder. In some cases, government officials approved the land-takings; in others, they took part in them. The earliest occurred before the Civil War; others being litigated today. Some of the land taken from black families has become...oil fields in Mississippi...*"

4. Accordingly, I am the fee simple owner of the aforementioned United States Federal Land Patent Number 27859, December 10, 1840, and claim the right to possession of tracts of land, situated in Washington County, containing 1361 acres, more or less, and being more particularly described as follows: *Section thirty four, the South half and the North East quarter of Section thirty five, and the South West quarter and West half of the South East quarter of Section thirty three, in Township sixteen, of Range eight West, in the District of Lands subject to sale at Jackson Mississippi containing thirteen hundred and sixty one acres and eight hundredths of an acre;* and that the Defendants wrongfully deprive me of possession thereof, for which damages amounting over \$75,000 dollars are here demanded and to be proven at trial. In addition, I demand of the Defendants damages for the

unauthorized use and engagement of timber and/or mineral operations and for the unauthorized occupation of my lands.

JURISDICTION AND VENUE

5. Personal jurisdiction over the Defendants is appropriate because they claim a legal interest in the Mississippi real property that is the subject of this action.
6. This Court has diversity jurisdiction of this matter under 28 U.S.C. §1332 because this is a civil action between citizens of different states and the amount in controversy is greater than \$75,000.
7. Venue is proper in this Court because the real property at issue is situated within this District, in Washington County, Mississippi.

Parties

8. At the commencement of this action and at all times hereinafter mentioned, Plaintiff Jennine Labuzan-Delane was a natural person, a citizen of the United States, and a resident of Athens Georgia.
9. At the commencement of this action and at all times hereinafter mentioned, Defendant COCHRAN & COCHRAN LAND CO. INC., was and is a corporation established under the laws of the State of Mississippi.
10. At the commencement of this action and at all times hereinafter mentioned, Defendant COCHRAN FARMS INC., was and is a corporation

established under the laws of the State of Mississippi.

11. At the commencement of this action and at all times hereinafter mentioned, Defendant LAKELAND FARMS LLC., was and is a corporation established under the laws of the State of Mississippi.

12. At the commencement of this action and at all times hereinafter mentioned, Defendant GREENLEE FAMILY LLC., was and is a corporation established under the laws of the State of Mississippi.

13. At the commencement of this action and at all times hereinafter mentioned, Defendant JENNINGS FARMS LLC., was and is a corporation established under the laws of the State of Mississippi.

14. At the commencement of this action and at all times hereinafter mentioned, Defendant David T. Cochran was a natural person, a citizen of the United States, and a resident of the State of Mississippi.

STATEMENT OF FACTS

15. This action concerns real property, located within Washington County, Mississippi, based upon a United States Federal Land Patent, pursuant to the Act of Congress of the 24th of April, 1820. The said Federal Land Patent was issued to three individuals on December 10, 1840, including my direct ancestor, Charles A. Labuzan, of which I have succeeded to his ownership.

The description of the land is as follows:

“Section thirty four, the South half and the North East quarter of Section thirty five, and the South West quarter and West half of the

South East quarter of Section thirty three, in Township sixteen, of Range eight West, in the District of Lands subject to sale at Jackson Mississippi containing thirteen hundred and sixty one acres and eight hundredths of an acre.

To have and to hold, the same together with all and singular the appurtenances thereunto belonging or in anywise appertaining, and all the estate, right, title, interest, lien, equity and claim whatsoever for the said first party, either in law or equity, to the only proper use, benefit and behoof of the said second party forever.” (A true certified copy of said United States Federal Land Patent along with its Plat is annexed herein as Exhibit B).

16. Upon information and belief, Defendant COCHRAN & COCHRAN LAND CO. INC., has been unlawfully possessing acres within sections 34 and 35 of my land.

17. Upon information and belief, Defendant COCHRAN FARMS INC., has been unlawfully possessing acres within sections 34 and 35 of my land.

18. Upon information and belief, Defendant LAKELAND FARMS LLC., has been unlawfully possessing acres within section 33 of my land.

19. Upon information and belief, Defendant GREENLEE FAMILY LLC., has been unlawfully possessing acres within sections 34 and 35 of my land.

20. Upon information and belief, Defendant JENNINGS FARM LLC., has been unlawfully possessing acres within sections 34 and 35 of my land.

21. Upon information and belief, Defendant DAVID T. COCHRAN has been unlawfully possessing acres within sections 34 and 35 of my land.

22. My superior title also exists in the Abstract Title Report,

notwithstanding the nearly one hundred years of color-of-title transactions on my private patented lands between bad faith possessors of my lands (A true copy of said Abstract Title Report is annexed herein as Exhibit C).

23. On or about December 10, 1840, notice was given to the world that United States Federal Land Patent 27859 was no longer part of the public domain when it was recorded with the United States Bureau of Land Management's General Land Office (A true copy of an image from the Bureau of Land Management's database of said United States Federal Land Patent 27859 is annexed herein as Exhibit D).

24. My heirship succession to ownership interest in the December 10, 1840 United States Federal Land Patent 27859 is also reflected in the April 28, 2022 Deed and Affidavit in Support, which are both recorded in the Mississippi Chancery Court (A true certified copy of said Deed and Affidavit are annexed herein as Exhibit E).

25. My title is good against the world, as an unbroken chain of title exists directly from the Sovereign United States Federal Government directly to me as an heir.

COUNT I – EJECTMENT

26. The foregoing paragraphs of the Complaint are incorporated by reference as if fully set forth herein.

27. This count is a cause of action for ejectment, brought pursuant to Mississippi Code Title 11 Chapter 19.

28. I, Jennine Labuzan-Delane, am the fee simple owner of the private patented lands that are subject of this action and hold superior legal title to said private patented lands pursuant to the United States Federal Land Patent 27859 issued to my ancestor Charles Labuzan and pursuant to the Abstract Title Report and pursuant to the recorded Deed and Affidavit in Support.

29. I have a right to immediate possession of the said private patented lands as the fee simple owner and heir of the original patentee.

30. My right to possession of the subject private patented lands comes directly from the sovereign United States Federal Government.

31. Defendants are in unlawful possession of my private patented lands.

32. Upon information and belief, Defendants have engaged in unauthorized timber and/or mineral operations on my private patented lands.

33. Upon information and belief, Defendants have generated millions of dollars during their unlawful possession of my private patented lands.

34. Upon information and belief, some Defendants have leasing agreements with entities and/or individuals for the purpose of engaging in unauthorized timber and/or mineral operations.

35. The Defendants' unauthorized possession and use of my private patented lands described herein have caused great injury to me by, among other things, preventing me from receiving my inheritance and preventing me from benefitting from the economic opportunities that would have provided financial stability and security to me and my children and my future

grandchildren.

PRAYER FOR RELIEF

36. **WHEREFORE**, Plaintiff prays for relief as follows:

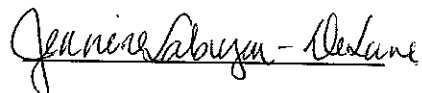
An award in favor of Plaintiff against all Defendants, jointly and severally, for all damages sustained as a result of Defendants' unlawful possession of my private patented lands and unauthorized engagement of timber and/or mineral operations in an exact amount that exceeds over \$75,000 dollars and to be determined at trial, including:

(a) Respectfully request that this Honorable Court establish and recognize me as the legal owner of my ancestral patented lands, as set forth in the aforementioned United States Federal land Patent 27859;

(b) Grant Plaintiff any further relief that this Honorable Court deems appropriate.
